**RULES & REGULATIONS**

**“EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT USEF RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.”**

**While every attempt has been made to avoid mistakes in this prize list, publication, website and/or email, Chagrin Hunter Jumper Classic, its management and employees assume no liability for errors. Any significant errors or changes will be disclosed to competitors whose entries are accepted in accordance with USEF Rules.**

The Horse Show Management reserves the right in itself to interpret all questions and conditions in regard to or arising out of an incident without claims for damages or recourse of any kind. All questions not covered in these Rules and Regulations shall be decided by the Horse Show Management, their decision to be final. The Horse Show Management reserves the right to limit entries, refuse, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors, prohibit exhibition of entries, and cancel award prizes, without claim for damages; to change any course, to add a dotted line, to cancel or combine any classes, or to reschedule classes, after due notice to exhibitors; to change rings or judges; to change specifications in jumper classes in order to facilitate the time schedule or as competition warrants, or make any changes management deems is in the best interest of the show and its exhibitors.

**2026 USEF MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes.

**FEDERATION ENTRY AGREEMENT:** I have read the United States Equestrian Federation, Inc. (the “Federation”) Entry Agreement (GR906.4) as printed in the Prize List for The Chagrin Hunter Jumper Classic (“Competition”) and agree to all of its provisions. I understand and agree that by entering this Competition, I am subject to Federation Rules, the Prize List, and local rules of the competition. I agree to waive the right to the use of my photos from the competition and agree that any actions against the Federation must be brought in New York State. The complete statement is as follows:

**Federation Entry Agreement:** By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the “Federation”) and the local rules of 2024 Winter Spectacular Show Series (Competition). I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable - casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4. If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF’s sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status. I acknowledge that I may opt out at any time by going to My USEF Dashboard or calling (859) 810-8733.

**STATEMENT AS TO FEDERATION FEE (GR407.1-3)** For every horse participating in any competition licensed by the Federation, a \$25 Federation Fee will be collected (\$15 shall be an Equine Drugs & Medication Fee to provide for research, inspection, and enforcement of rules regarding use of medications and drugs & \$10 USEF Fee) along with a \$10 USHJA Fee and USHJA Showpass \$30. USEF Membership is required.

**SAFE SPORT STATEMENT:** All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org). As of Jan 1, 2019 every USEF adult member (18 years of age or older) must complete USEF's Safe Sport Training. Failure to complete the safe sport training will disqualify you from competing in any capacity until it is completed.

**MOTORIZED VEHICLE STATEMENT.** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

**ENTRIES:** Competitors are required to submit their show entries online at <http://www.horshowsonline.com/> Entries will close **June 25, 2026**. ANY ENTRIES RECEIVED AFTER 5PM on CLOSING DATE WILL BE CHARGED A \$20 LATE FEE FOR OPENING WEEK SHOW; \$50 LATE FEE FOR USEF RATED SHOW. Entries will be accepted ONLY when signed by the owner or his exhibitor's agent, trainer and rider and accompanied by a check or credit card. Be sure to include the USEF/USHJA Membership Numbers of your trainer, rider and owner's on the entry form. No numbers will be released until proper credentials and all signatures are in order and form of payment received. All exhibitors in Amateur sections must present their Amateur certification at the office before numbers will be released.  
**Non-member USHJA fee \$30 to USHJA.**

**STALL RESERVATIONS:** Stall Reservations must be made by contacting Linda Joseph (440.488.8777). **STALL RESERVATIONS WILL NOT BE CONFIRMED UNTIL FULL PAYMENT IS RECEIVED. TACK STALLS MAY BE LIMITED.**

**USEF/USHJA CREDENTIALS AND MEASUREMENT CARDS:** To be eligible to compete at Federation Licensed Competitions, coaches, trainers, and legal guardians signing as coaches or trainers on behalf of their minors must be Senior Active Members in good standing, as defined herein. All participants must present to the show secretary current USEF and USHJA membership cards or copies thereof. Amateur certification, and measurement cards for Small Junior Hunters and Pony Hunters must be presented to the horse show secretary before numbers will be issued. Horses and ponies without a current valid measurement card issued by USEF will be measured by the horse show steward.

**USEF SHOW PASS FEE:** Any rider, handler, driver, or owner are limited to one USEF Show Pass purchase annually (December 1-November 30). USEF Show Pass will be available for purchase by exhibitors online only. USEF Membership will be required in order to compete for anyone who has not purchased a Show Pass through their USEF portal. **Trainers, Coaches or Parents signing as Coaches are no longer eligible to participate under a Show Pass and must be an Active USEF member and complete Safe Sport Training.**

**HORSE IDENTIFICATION GR1101** All horses competing in Federation licensed competitions must be properly identified. For all such competitions, entries for each horse must include a **Federation-issued Unique Horse Identification Number (HID)**. Additionally, a **Federation Recognized Discipline Affiliate may require horses to be registered with their organization, and if so, the entry must also include that registration number.**  
**USHJA Horse Registrations.** All horses competing in Federation non-breed restricted competitions must obtain a **Registration Number from USHJA** (exception: opportunity, academy, exhibition, walk-trot and lead line). A registration number for each horse must be entered on all entry forms.

**MICROCHIPPING.** Mandatory Microchipping went into effect on December 1, 2018. You will not be allowed to compete with any horse that has not been microchipped. The microchip must be uploaded to your USEF account. All horses that require a USHJA Registration will also require microchip. Exceptions: USHJA Outreach and those activities enumerated in GR901.9, items 1-9.

**HORSE/PONY MEASUREMENTS:** Measurement times and location will be posted in the Show Office. Please make arrangements in the Horse Show Office.

**HORSE/PONY HEALTH REQUIREMENTS:** All animals entering the show grounds, whether competing or for schooling only, must present a current negative Coggins test dated within a year of that competition. Per **USEF GR-844 Equine Vaccination Rule:** At Federation Licensed Competitions, horses entering the grounds must be accompanied by documentation of Equine Influenza Virus & Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months of entering the stables. Horses not in compliance with this rule will be required to leave the competition grounds upon request by Competition Management. **NO EXCEPTIONS!** Email health records to [chjchealthrecords@gmail.com](mailto:chjchealthrecords@gmail.com)

**SHIP-INS: NO SHIP-INS WILL BE ALLOWED. ALL HORSES MUST BE STABLED.**

**NON-SHOWING HORSES:** All horses on the grounds are required to have a signed entry form and Waiver in the office, whether showing or non-showing. This entry form must include signatures and a complete description of the horse. Non-Showing horses will pay a non-showing fee of \$50 Opening Week / \$100 Rated Week.

**NIGHT WATCH:** (USEF RATED WEEK only) All horses occupying a stall (showing or non-showing) will be charged a \$25 Night Watch Fee.

**EMERGENCY INFORMATION:** All horses must have emergency information attached to their stall.

**MANAGEMENT:** Management reserves the right to cancel or combine classes if insufficient entries warrant. Management reserves the right to refuse any entry in accordance with GR914. Divisions will be combined based on USEF rules. **PLEASE NOTE:** Concerning splitting/combining and add/scratch policies in all Rated hunter sections – should entries warrant, all Rated hunter sections will be split or combined following USEF rules and will be done so at the close of the horse show office on the evening preceding the first class in each section, therefore entries must be completed for the Rated hunter divisions accordingly to be considered. Any post adds received and accepted after this time will not be considered in respect to the splitting/combining. There will be no exceptions to this policy. Same day scratches and/or no shows at the gate in all Rated hunter sections will forfeit their entry fee unless the official show veterinarian supplies a certificate warranting a scratch from the show. This certificate must be received by the official show secretary prior to the section in question. Should same day scratches and/or no shows result in insufficient entries to keep sections split, sections will be combined.

**RESPONSIBILITY:** The Chagrin Hunter Jumper Classic and Chagrin Valley Farms, the owner, their officials and employees will not be responsible for any accident or loss which may occur to an exhibitor, spectator, guest, rider, groom, attendant, or other employee, animal or equipment at the show. **\*\*THIS WILL BE A CONDITION OF ENTRY TO THE SHOW AND SHOW GROUNDS\*\***  
Under Ohio Law, an equine activity sponsor, equine activity participant, equine professional, veterinarian, farrier, or other person is not liable in damages in a tort or other civil action for harm that an equine activity participant allegedly sustains during an equine activity and that results from an inherent risk of an equine activity pursuant to Ohio Revised Code Annotated § 2305.321 (2001).

**PRIZE MONEY** will be credited to show bills or paid within 30 days following the conclusion of the show via check. Prize money and refunds will be made payable to the owner of the horse unless otherwise indicated in writing to the show office. A valid SSN or Tax ID information is required for all payments. \*Please note, tax identification numbers are required to pay out horse show prize money. **REFUNDS:** Entry fees will not be refunded unless a certificate of illness or injury prepared by an accredited veterinarian is presented to the secretary before the start of the show. Once the show has started, horses which are not shown in classes which they have entered, forfeit their entry fees, except if a horse is injured or becomes ill prior to the class or classes that are being scratched. This must be accompanied by a certificate from the official show veterinarian. **Office & stall fees are nonrefundable for any reason after the closing date.**

**NON-NEGOTIABLE CHECKS/CREDIT CARD CHARGEBACKS:** Checks returned by the bank, declined credit cards, or chargebacks on credit card transactions for any reason will be handled as follows: A 10% Penalty will be assessed for every returned check or credit card chargeback (**Minimum of \$50**). Accounts will be given ten days to be paid in full with cash or cash equivalent or they will be reported to USEF for collection/ disciplinary action.

**SHOW CHAMPIONSHIPS:** Points awarded for all divisions as follows: 10-6-4-2-1-1/2 except Jumper bonus classes (15-9-6-3-2-1). In all Hunter Divisions with two (2) or more Over Fences and one (1) Under Saddle, Championship and Reserve shall be awarded to two (2) of the four (4) horses which have acquired the most points over fences. In addition to these points, only these four (4) horses shall receive full points for ribbons won in Under Saddle classes and half points for ribbons won in Model. In Equitation Sections with two (2) or more Over Fences and one (1) Flat, Champion and Reserve shall be awarded to the top two (2) of the four (4) riders that acquired the most points over fences. In addition to these points, only these four (4) riders receive points for ribbons won in one (1) flat class. In case of a tie score, the Championship and/or Reserve is awarded to the rider that accumulated the most points over fences. Ties in USEF Hunter Championships shall be decided as specified in the USEF Rule Book. Others shall remain tied and shall flip/draw for the awards. In Jumper Divisions a minimum of three (3) classes must be held to award Championships. Ties in Jumper divisions to be decided by the bonus class placing, if still tied they shall remain tied and entries shall flip/draw for the awards.

**JUMPER ORDER.** A rotating jumping order may be established for all classes over fences. Management reserves the right to draw and post an order of go. Riders or trainers who have conflicts due to multiple entries in a class must see the starter so that necessary adjustments can be made.

**COURTESY CIRCLE:** The area of the courtesy circle may be restricted by a mandatory line that will be indicated on the course diagram and a corresponding barrier will be erected on the course.

**FOOTING AND ARENA SIZES:** Two (2) Hunter rings are 130' by 260' with SRS footing by Footing First. Schooling ring is a limestone/sand mixture. Jumper ring is 200' by 300' with SRS footing by Footing First. Jumper schooling is 100'X200'.SRS footing. Two (2) lunging areas are a sand mix.

**DRUGS AND MEDICATIONS** Current USEF rules and regulations regarding D & M will be enforced. Sharps and medical waste must be disposed of in sharps containers placed around the barns. All competitors are asked to comply with the USEF Testing Veterinarians in a courteous and efficient manner. **Please note that sharps containers MUST be used as provided in stabling areas or penalties will occur. (GR1210.4)** All showing horses will be invoiced the USEF D & M and USEF Fee of \$25.

**SCHOOLING, WARMUP, LUNGING:**

**NEW USEF RULE HJ106.c.d.e.:** All horses in the schooling area or warm-up area must have its show number attached to the horse or the individual riding or handling. Any horse without its correct number will be asked to leave the area. All horses in the exercise area must have their show number attached to the horse or the individual exercising. Any horse without its correct number will be asked to leave the area. All horses being lunged in the designated lunging area, or anywhere else on show grounds, must have its show number attached to the horse or the individual lunging. Any horse without its correct number will be asked to leave the area.

**TICKETED SCHOOLING:** ALL horses must be entered with paperwork completed/on file with show office prior to schooling. **BACK #s MUST BE WORN** for ticketed schooling (\$25-Rated Show). See New USEF Rule HJ 106. Additional ticketed schooling may be allowed, weather permitting in the afternoons on show days. Hacking/Hand walking in the hunter rings will be allowed up to approximately 45 min before official showtime (weather pending). No flatting in the jumper ring at any time after schooling day unless otherwise specified with management. **THERE WILL BE NO SCHOOLING IN THE RINGS ON THE MORNINGS OF SHOW DAYS.** No poling or offset oxers will be allowed at any time.

**HEAD GEAR:** It is compulsory for all persons at Federation licensed hunter, jumper, or hunter/jumper competitions when mounted anywhere on the competition grounds, to wear properly fastened protective headgear in compliance with the accepted testing standards published on the Federation's website. Protective headgear must carry the applicable quality testing tag and/or label. It must be properly fitted with harness secured.

**ELECTRONIC DEVICES:** The unsafe use of electronic devices, as determined by the competition steward in their sole discretion, including cell phones, with or without earphones/buds while mounted is prohibited in all areas designated for schooling and exercise, and while lunging horses on competition grounds. Earphone(s) / Earbud(s) are prohibited in all areas designated for schooling & exercise.

**DOGS:** Dogs must be leashed at all times. Per USEF Rule GR1301.6 dogs are not permitted to be loose on competition grounds and must be on a leash or otherwise contained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule may be subject to penalty under Chapters 6 and 7, as well as issuance of warning cards.

**PLEASE TAKE NOTE:**

No smoking is permitted in any barns / buildings.

**Biosecurity**

**EQUINE COMPETITION HEALTH & BIOSECURITY REQUIREMENTS**

To ensure the safety of all equine exhibitors showing at Chagrin Valley Farms, CVF management has put in place the following health and safety protocols for horses at **all** shows and competitions (rated shows, schooling shows, dressage, mini-trials, etc.) beginning in March 2024. Great biosecurity is a team effort and begins at home; please do not ship horses to CVF who have elevated temperatures.

**Negative Coggins (within twelve months)** – Proof of a current negative Coggins test within 12 months.

**Vaccinations (within six months)** – It is required all horses be vaccinated for Equine-EHV I/IV (either modified live or killed vaccine) and Equine Influenza no sooner than seven days prior to and no later than 180 days (six months) prior to entering the show grounds. Most EHV-1 vaccines are only considered effective for 180 days. Please check with your veterinarian about which vaccine is right for your horse. We strongly recommend vaccinations against WNV, EEE, WEE, Tetanus and Rabies.

**Statement of Health or Health Certificate (14 days)** – Required for all horses arriving from outside the state of Ohio. The statement of health must be dated within 14 days of check in, affirming that the horses entering the facility have not had an elevated temperature, been to a facility where there has been a positive or suspected positive case of EHV, been in a close proximity to an ill horse and receive routine vet care and vaccinations. The Statement of Health must be signed by a licensed veterinarian and on the vet's letterhead.

\*Please note, a health certificate will be accepted to meet the health statement requirement, if it is dated within 14 days of check-in.

**We prefer health papers emailed before arrival, but visitors/competitors may also present health papers to the show office before horses are unloaded from the trailer. Send forms and health paperwork to [chjchealthrecords@gmail.com](mailto:chjchealthrecords@gmail.com)**

**After Arrival**

**No Use of CVF Pastures or All-Weather Turnouts**

Visiting horses are NOT allowed to use CVF pastures or turn-outs while on the property. Violators will be fined and repeat violators will not be allowed to return for future shows.

**Reporting to Show Management**

Any temperature over 101.5F degrees or abnormal clinical signs must be reported immediately to the Show Veterinarian and Horse Show Manager immediately. The Show Veterinarian will examine the horse to determine if isolation or testing of the horse for a potential equine infectious disease is necessary. CVF reserves the right to test any horse that has a fever and/or clinical signs for an infectious disease at owner expense.

CVF has a 3-stall quarantine barn to house horses during assessment and in case horses must be retained on the property for quarantine before returning to their home facility. When the show veterinarian deems that a horse must be quarantined, it must be housed in this facility or removed from the property immediately (if allowed).

**Show Management Notification to Competitors**

Should a risk case be identified, show competitors will be notified through a combination of show announcements, SMS messages, and direct messaging with competitors that a case is being investigated. Updates will be sent as soon as they are available.

**Practice and communicate biosecurity best practices to your barn staff.**

**Post Show/Competition**

If your horse begins to display a fever or clinical signs of a contagious nature within 14 days of departing, please notify CVF immediately for tracking purposes.

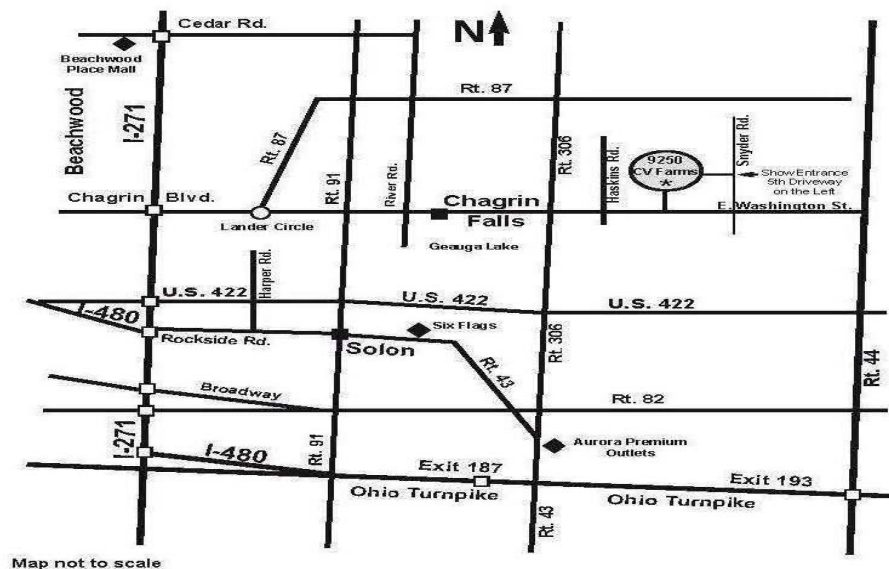
